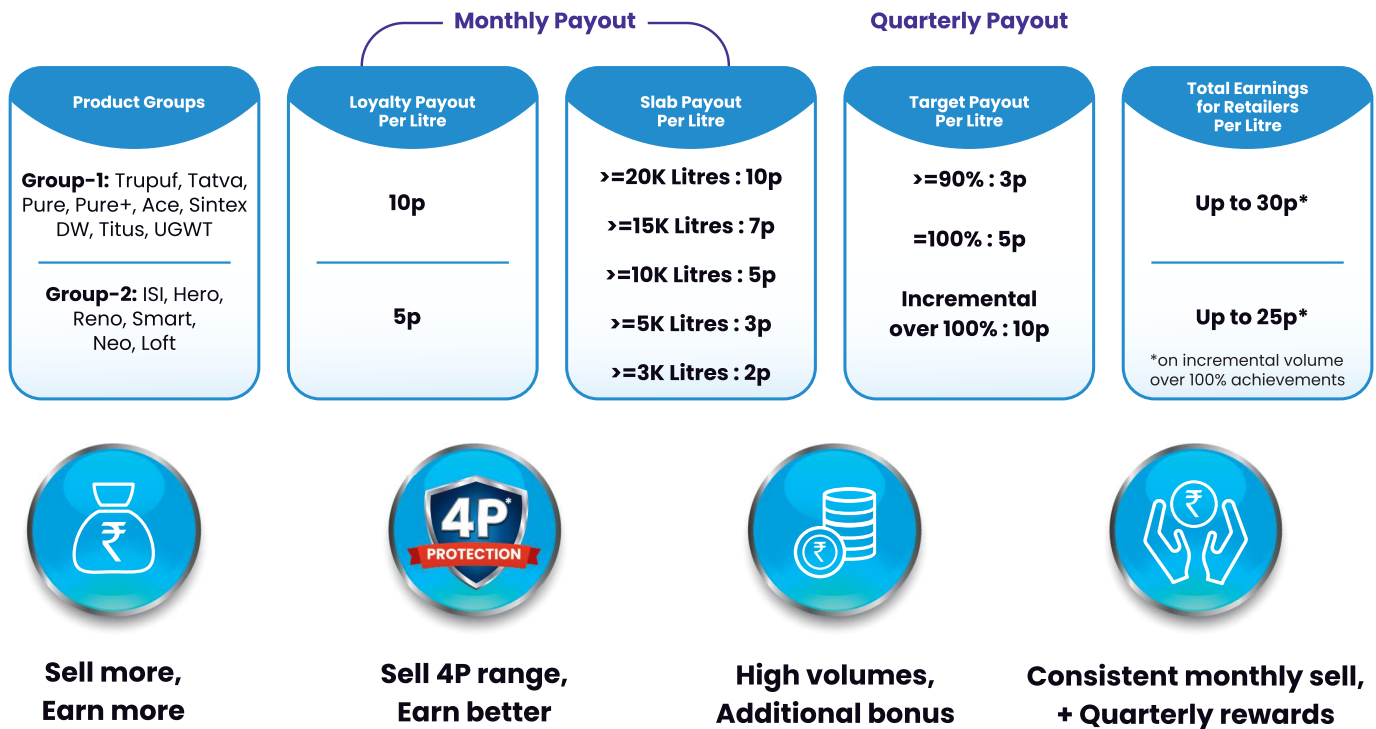

Sintex Hamesha Program

Terms & Conditions:

- This program will be effective from 1st April, 2025.
- The Sintex Chairman's Club is for FY 2025-26.
- The program is open for enrolment for dealers who buy Sintex Water Storage Tanks of the Company directly only from the authorized distributors of the Company.
- To qualify for rewards accrual and redemption, the dealer must be registered and verified in our system.
- Quarterly targets will be sent to the dealers via Message, WhatsApp; you can also confirm that with the sales team and always check your Quarterly Target in the Sintex Hamesha App.
- The Sintex Chairman's Club is applicable for retail sales only. Project sales of Sintex Water Storage Tanks will not be considered.
- Dealers to ensure that billing should be done through Sintex Shikhar DMS as rewards will be considered only for sales done through Sintex Shikhar DMS from their associated distributor.
- Any related party or sister concern of a distributor or own firm of distributor cannot take part in this scheme.
- The company shall deduct TDS on the equivalent value of all rewards in accordance with Section 194R of the Income Tax Act, 1961. Dealer is responsible to provide Permanent Account Number (PAN) details.
- Sintex reserves the right for the computation of the reward that shall be final, conclusive and binding on the dealer and will not be liable to be disputed or challenged.
- The Reward Points can be redeemed in full or in part. Dealer can redeem up to 80% (eighty percent) of the accumulated reward points at any stage of the program.
- Trip eligibility would be considered based on qualified and fully paid billing done during the scheme period. Switching of destination or any other change will not be allowed.
- Only dealers who have been added, verified and billed in system till 30 June 2025, and have achieved 80% (eighty percent) of their Q1 FY 2025-26 target will be valid for the The Sintex Chairman's Club with mandatory billing required in all subsequent months till March 2026 (min 9 months billing out of 12).
- This scheme is only applicable on the purchase of Sintex Water Storage tanks.
- Wholesalers under any DP who are trading in their areas will not be eligible to take part of this scheme. However their dealers can be enrolled under the DP and given Hamesha scheme benefits. DP has to ensure DMS punching under that dealer only.
- Sintex holds all rights to change and amend the terms and conditions of this scheme without prior information/Notice.
- Points earned in Sintex Hamesha Dealer Loyalty program from 01st April, 25 are valid for redemption within two (2) years from their accrual date
